## What is this product?

### TYPE OF PRODUCT

The product is a sub-fund of Protea Fund, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

### TERM

The Sub-Fund is established for an unlimited duration. However, the board of directors may also propose to dissolve a sub-fund at a general meeting of that sub-fund.

### OBJECTIVES

#### Objectives and investment policy

The Sub-Fund's objective is to provide capital growth by offering mainly an exposure to equities and equity-related securities (among other rights, ADR (American Depositary Receipt) and GDR (Global Depositary Receipt)) listed in the US. The Sub-Fund is not subject to any specific industry sector constraints, although, without being a constraint, the Investment Manager intends to focus on companies which are involved in innovation sectors such as robotics, security, digital and healthcare.

In order to achieve its objective, the Sub-Fund will mainly invest directly in the securities above-mentioned; and/or in UCIs (UCITS and/or other UCIs referred to in Section 23.3(e) of the main body of the prospectus), having as main objective to invest or grant an exposure to the securities above-mentioned (within the 10% limit mentioned below). On an ancillary basis, the Sub-Fund may invest in any other type of eligible assets, among others, cash and equities other than those mentioned above.

The Sub-Fund will not invest more than 10% of its net assets in UCITS and/or other UCIs.

If the Investment Manager considers this to be in the best interest of the Shareholders, on a temporary basis and for defensive purposes, the Sub-Fund may also hold up to 100% of its net assets in cash and cash equivalents, as among others cash deposits, money market UCIs (UCITS and/or other UCIs referred to in Section 23.3(e) of the main body of the prospectus, within the 10% limit mentioned above) and Money Market Instruments.

**Derivatives** For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments traded on a Regulated Market and/or OTC provided they are contracted with leading financial institutions specialized in this type of transactions and subject to regulatory supervision. Nevertheless, in normal market conditions, the Investment Manager intends to use listed options and futures offering an exposure to equities and currency derivatives (such as forward foreign exchange contracts).

**Benchmark** The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

**Dividend Policy** This Class is cumulative. Dividend distributions are not planned.

**Share Class Currency** The currency of the Class is USD.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

### INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

### OTHER INFORMATION

**Asset segregation** The assets and liabilities of each sub-fund are segregated by law, which means that the performance of the assets in other sub-funds does not influence the performance of your investment.

**Dealing** The NAV for this Class is calculated on each Wednesday (the "Valuation Day") based on the pricing day as of Tuesday. The cut-off time to submit subscription and/or redemption orders is 4 p.m. Luxembourg time on the bank business day preceding the relevant Valuation Day.

**Switching** Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target class or sub-fund are fulfilled with respect to this sub-fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. ## What are the risks and what could I get in return?

### Risk indicator



The risk indicator assumes you keep the product for 5 years.

## What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depository, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depository's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depository is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depository will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depository.

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.
