What is this product?

TYPE OF PRODUCT

The product is a sub-fund of ZEST ASSET MANAGEMENT SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the Fund may decide to close this product under certain circumstances.

OBJECTIVES

Objectives and investment policy

In order to capitalise on attractive opportunities, while minimising risk, the Investment Manager shall allocate the Sub-Fund's investments across a diversified universe of corporate bonds, convertible bonds, contingent convertible bonds (for a maximum of 20% of the Sub-Fund's net assets with respect to the latter) and sovereign bonds.

The Sub-Fund shall invest primarily in fixed and/or floating bonds in both the corporate, sovereign and Supra-national segment, without any focus on any duration, but which are consistent with the Sub-Fund's investment objectives. The Sub-Fund can be exposed to Investment Grade debt securities and Non-Investment Grade debt securities, in proportions that will vary according to financial market conditions and investment opportunities.

The Sub-Fund will not invest more than 10% in bonds which are not rated (either at issue or the issuer level). If the Bonds issuer/ the issue has not been given a credit rating by a recognized agency, the Board of Directors may appreciate whether one instrument possesses the equivalent of at least High Yield rating criteria. Without being a constraint, the expected average rating will be BBB- / BB+. The Sub-Fund will not invest in Distressed Securities or Defaulted Securities. It is understood that, in the event of downgrading in the credit ratings of a security or an issuer to distressed or defaulted, the Sub-Fund may, at the discretion of the Investment Manager, and in the best interests of the Sub-Fund's shareholders, continue to hold those debt securities which have been downgraded, provided that in any case the Sub-Fund's maximum exposure to Distressed Securities or Defaulted Securities will be limited to a maximum of 10% of its net assets.

Moreover, the Sub-Fund will hold a diversified portfolio of bonds over a broad base of issuers, industries and geographies to mitigate credit risks. The Sub-Fund is not expected to have any bias towards any specific industrial, geographic or other market sector.

The Investment Manager shall manage the credit risk and will aim to manage interest rate risk through credit analysis and credit diversity; combine traditional corporate bond analysis with a clear understanding of market factors and valuations; consider the following factors in evaluating securities for purchase by the Sub-Fund, including: a. Yield to maturity, yield to call (where appropriate), current yield and the price of the security relative to other securities of comparable quality and maturity; b. The issuer's financial resources and financial condition, including leverage and cash flow to cover interest expense and principal repayment; c. The terms under which securities are issued and the nature of the securities and coverage under financial covenants; d. The size of the issuer and the issuer's operating history; and e. Market-technical factors, including prevailing market conditions and the amount of new high yield securities being issued.

The allocation will be done either directly or indirectly through other UCITS and/or UCIs (limited to 10% of the Sub-Fund's net assets). The Sub-Fund may invest up to 20% of its net assets in structured products. The Sub-Fund may be exposed, directly or indirectly, for up to 10% of its asset to Emerging Markets. The Sub-Fund will not invest directly in ABS/MBS (this limit is waived for indirect investments such as target funds, i.e. no look-through); directly in equities and equity-related securities (exception made of convertible bonds and/or financial derivative instruments underlying equity products). The Sub-Fund will not enter in TRS.

Derivatives For hedging and for investment purposes, the Sub-Fund may use all types of financial derivative instruments. Nevertheless, in normal market conditions, the Investment Manager will largely favour futures and options.

Benchmark The Sub-Fund is actively managed without reference to any benchmark meaning that the Investment Manager has full discretion over the composition of the Sub-Fund's portfolio.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTOR

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

The minimum subscription amount for the Class is 1,000 EUR.

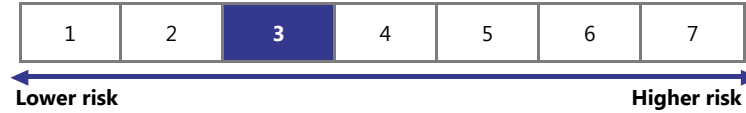
Switching Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target share class, type or sub-type, are fulfilled with respect to the Sub-Fund, on the basis of their respective NAV calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What are the risks and what could I get in return?

Risk indicator

What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depository, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depository's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depository is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depository will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depository.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
