You are about to purchase a Product that is not simple and may be difficult to understand.

What is the product?

Type: This Product is a common fund qualifying as an 'other fund for traditional investments' in accordance with the Swiss Federal Act on Collective Investment Schemes.

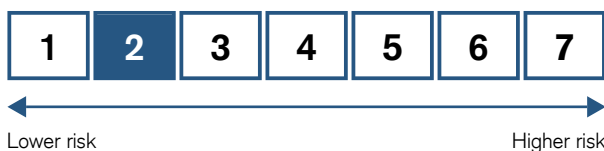
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Management Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The primary investment objective of this Sub-fund is to earn an appropriate return in the unit of account by investing directly in debt instruments and rights denominated in Swiss francs of all types from issuers worldwide (including emerging markets), which generally have a credit rating from a rating agency recognized by the supervisory authority, a banking rating, or an implied credit rating of at least BBB- or equivalent. The principles of risk diversification, security of capital, and liquidity of the assets in the Sub-fund must be taken into account.

Intended Retail Investor: This Product is intended for professional and institutional investors, as well as sophisticated retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 2 out of 7, which is a low risk class and poor market conditions are very unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator. Recommended holding period: 5 years

The recommended holding period is calculated based on the Summary Risk Indicator presented above. The investor can sell their investment on a daily (on business days) basis. Redemption fees will be charged at the level of the Product.
