## What is this product?

### Type

UBS (Irl) Fund Solutions II ICAV is an open-ended umbrella ICAV with segregated liability between sub-funds incorporated in Ireland and authorised by the Central Bank as an Undertaking for Collective Investment in Transferable Securities pursuant to the UCITS Regulations.

### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

### Objectives

The Fund will seek to track the MSCI Emerging Markets Climate Paris Aligned Index (Net Return) (the 'Index'). The Index is a subset of the MSCI Emerging Markets Index (the 'Parent Index') which is an equity index that includes large and mid-cap stocks across emerging markets and excludes companies engaged in business activities contrary to certain social norms (as described by the Index Provider). The Index is designed for investors who wish to manage potential risks associated with the transition to a low carbon economy by addressing two dimensions of carbon exposure – carbon emissions and fossil fuel reserves. The Index aims to reflect a lower carbon exposure than the Parent Index by overweighting companies with low carbon emissions relative to sales and those with low potential carbon emissions per dollar of market capitalisation. The Fund will be constructed by investing in the components of the Index. It invests at least 90% of its total net assets in securities that are constituents of the Index and the index provider applies ESG Ratings on all of the Index constituents. At least 90% of the securities, excluding cash, money market funds and derivatives have an ESG rating. The weighted average environmental indicator (Carbon Intensity (1 and 2) emissions indicator of the Fund as the relevant extra-financial indicator of the Fund will be at least 20% lower than the weighted average environmental indicator of the Parent Index. The Fund may also hold securities which are not comprised in its Index, including, for example, securities which are expected to shortly be included in the Index. The Fund may, to reduce risk, reduce costs or generate additional capital or income, use derivative instruments. The use of derivative instruments may multiply the gains or losses made by the Fund on a given investment or its investments generally.

This Fund promotes environmental and/or social characteristics but does not have a sustainable investment objective.

The Fund will not enter into any securities lending.

The return of the fund depends primarily on equity market development and dividend payments.

Fund income is not paid out, but instead will be reinvested.

### Intended retail investor

This fund applies to professional investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is only suited to be acquired within a discretionary mandate.

### What happens if UBS Fund Management (Ireland) Limited is unable to pay out?

Losses are not covered by an investor compensation or guarantee scheme. Furthermore, with respect to State Street Custodial Services (Ireland) Limited as depositary of the Fund, which is responsible for the safekeeping of the assets of the Fund (the "Depositary"), there is a potential default risk if the assets of the Fund held with the Depositary are lost. However, such default risk is limited as the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary is liable to the Fund or to the investors of the Fund for the loss by the Depositary or one of its delegates of a financial instrument held in custody unless the Depositary is able to prove that the loss has arisen as a result of an external event beyond its reasonable control.

## What are the costs?
