What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

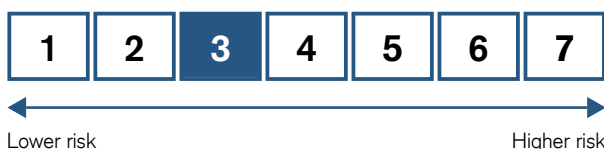
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund is actively managed with reference to ICE BofA BB-B Rated Developed Markets High Yield Constrained Index (the "Benchmark") seeking to invest primarily in fixed and floating-rate income securities, bonds, mortgage- and other asset-backed securities (including collateralized debt obligations) and convertible securities with financial performance and high level of sustainability. The Sub-fund has a sustainable investment objective (within the meaning of Article 9 of Regulation (EU) 2019/2088). Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Investment Manager will use its discretion to deviate the weighting of certain components of the Benchmark and to invest in companies or sectors not included in the Benchmark in order to take advantage of specific investment opportunities. It is thus expected that the performance of the Sub-fund will substantially deviate from the Benchmark. At least two thirds of the Sub-fund's net assets are invested in non-investment grade debt securities with a rating of BB+ or below determined by Standard&Poor's, Moody's or from another recognized rating agency or deemed to be of the same credit quality by the Investment Manager, as well as the market-implied rating. The Sub-fund may invest up to 20% of its net assets in money market instruments and/or in other liquid assets including investments in the form of sight deposits. The Sub-fund invests without being limited to a specific currency, geographic region or industrial sector; a proportion of the Sub-fund's assets may be invested in Emerging Markets (up to 10%). In order to reach its objective, the Sub-fund can use derivative instruments to protect against movements in currencies and security prices and for efficient portfolio management. The Sub-fund uses derivatives to reduce the impact of changes in currency exchange rates on the performance for this Share Class. The investor can buy or sell shares on a daily basis (Luxembourg bank business days). This Share Class does not make distributions. The Sub-fund shall bear the costs of standard charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for professional and institutional investors, with an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 3 out of 7, which is a medium-low risk class and poor market conditions are unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies.
