What is this product?

Type

UBS (CH) Property Fund – Europe (the "real estate fund") is a contractual investment fund of the type "real estate fund" within the meaning of Art. 25 et seq. in conjunction with Art. 58 et seq. of the Swiss Federal Act on Collective Investment Schemes (CISA) of 23 June 2006.

Term

This product does not have a maturity date (in other words, it is open-ended). The manufacturer may terminate the product early. The amount you would receive if such early termination took place might be lower than the amount you invested.

The recommended holding period (RHP) is displayed in the section "How long should I hold it and can I take money out early?".

Objectives

The primary investment objective of the real estate fund is to achieve long-term earning power and a continuous increase in the value of the real estate portfolio, based on careful use of non-renewable resources and actions to support climate protection in the international, broadly diversified portfolio of properties. The fund management company embeds sustainability into standards, strategy and operations, making it central to all decisions taken, be that in relation to the real estate funds managed, the underlying properties or the ongoing development of the organisation. The UBS (CH) Property Fund – Europe invests primarily in office, retail, industrial and logistics properties throughout the European Union and in EFTA member states (excluding Switzerland) and the United Kingdom; investments are permitted in countries where there is assurance that fair values can be determined in accordance with Swiss regulations. It also invests in other investments as permitted under the fund contract. The fund's return depends primarily on the supply of and demand for listed Swiss real estate funds and on rental income and interest rates.

This share class is a distributing share class. The share class may pay dividends. The exchange rate risk of the share class currency is to a large extent hedged against the currency of the fund.

Intended retail investor

This fund applies to retail investors with an advanced financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at preserving the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is suited to be acquired subject to a test of the investor's financial knowledge and experience.

What happens if UBS Fund Management (Switzerland) AG is unable to pay out?

What are the costs?

How long should I hold it and can I take money out early?

Recommended holding period: 3 Year(s)
