WHAT IS THIS PRODUCT?

Type:

Collective investment scheme in accordance with the Swiss Federal Act on Collective Investment Schemes (CISA). The fund's performance depends on the performance of the underlying investments, as further described in the «Objectives» section.

Term:

The term of this product is indefinite and it has no maturity date. The manufacturer may reposition the product at any time, merge it with another product or terminate it unilaterally and without notice.

Objectives:

The investment objective of the investment fund is primarily to generate long-term capital growth, combined with an appropriate return. This is achieved principally by means of direct investments in equity securities and rights in companies in North America.

The fund is actively managed. The investment universe for the main investments is the benchmark index; deviations from the investments and investment weightings in the benchmark index are permitted. At least 70% of the investments are part of the asset manager's sustainable investment universe. Reference index: MSCI® North America Index TR Net

Fund units are issued and redeemed basically on every bank business day in Switzerland. Earnings and profits of the unit class are not distributed, but reinvested. Cantonal Bank of Zurich, Bahnhofstrasse 9, 8001 Zurich, was appointed as the custodian bank. The liability of the assets of a fund within the umbrella fund for claims against the assets of another fund is excluded.

Risk indicator

WHAT HAPPENS IF SWISSCANTO FUND MANAGEMENT COMPANY LTD., ZURICH, IS UNABLE TO PAY OUT?

The assets of the Fund and the assets of the fund management company are held separately. Therefore, a default by the fund management company will not affect the value of your investment. If the custodian bank goes bankrupt, the Fund's assets deposited with the custodian bank will not be included in the bankruptcy estate but will be segregated for the benefit of the Fund. In such a case, the claims by the Fund against the custodian bank in the form of privileged deposits are given priority by the custodian bank, but are otherwise treated as ordinary claims in the bankruptcy proceedings.
