## What is this product?

**Type I** Mandarine Global Sport is a sub-fund of a SICAV (Société d'Investissement à Capital Variable) under Luxembourg law. Each shareholder has a right of co-ownership in the assets of the SICAV in proportion to the number of shares held.

**Duration I** The UCI was created on 31/12/2020 and its expected lifetime is 99 years.

**Objectives I** Mandarine Global Sport (the "Fund") is an international equity fund whose objective is to provide investors with long-term capital growth from a diversified portfolio of shares from companies of all capitalisation sizes and from all geographic regions whose economic model and products or services are involved in or offer solutions to issues relating to sport, and to achieve a higher net performance than the MSCI ACWI Net Total Return EUR Index (all countries world index) NR (the "Index").

The investment strategy is based on the selection of growth-type companies of all capitalisation types which are delivering above-average growth, in particular in terms of their results and margins, and which have the potential to increase in value.

The investment strategy is based on active management carried out on the basis of a "bottom up" approach in order to select companies which offer solutions or contribute positively or are involved in sports-related issues (sports infrastructure, sporting equipment, sporting accessories, sports economics, performance measurement and medical assistance, e-sport, sports nutrition).

To this end, the sub-fund will, more specifically, endeavour to select companies whose turnover is mainly exposed to one or more of the aforementioned sports-related investment issues. The sub-fund shall also apply a "Best-In-Universe" extra-financial strategy which consists of favouring the best rated issuers from an extra-financial point of view, regardless of their field of activity. Mandarine Gestion's ESG expertise unit attributes extra-financial scores to the securities. The extra-financial analysis results in a five-step ESG score from A (best score) to E (worst score).

The following are excluded from the Fund's investment universe:

- · Issuers with the most unfavorable ESG rating ("E" rating),
- Issuers whose head office is located in high-risk jurisdictions or noncooperative territories or countries considered at risk from a tax point of view according to internal analysis (tax haven, tax opacity, etc.);

 The following issuers: professional football clubs and companies engaged in the sale of weapons;

The Sub-fund will invest at least 75% of its net assets in equities issued by companies operating in sectors related to sport in any geographic area.

The sub-fund may invest up to 30% of its net assets in shares of companies located in emerging countries and, in particular but not limited to, "A-Shares" through the Shanghai-Hong Kong Stock Connect and/or the Shenzhen-Hong Kong Stock Connect programme (together, the "Stock Connects"). The sub-fund shall also be authorised to invest up to 25% of its net assets in money market instruments or debt securities.

Management objective: To achieve a higher return than that of its benchmark index.

The Fund takes sustainability risks and ESG characteristics into account in its selection process. In this regard, the Fund promotes environmental or social characteristics within the meaning of Article 8 of the SFDR Regulation. The Fund is subject to a sustainability risk as defined in the risk profile of the prospectus.

## What are the risks and what could I receive in return?

#### Performance scenarios (amounts expressed in euro) I

We have classified the product in risk class 5 out of 7, which is a medium to high risk class. This means that the potential losses associated with the future performance of the product are in the medium to high range and, should the situation on the financial markets deteriorate, it is likely that our ability to pay you will be affected.

**Discretionary management risk I** The management style is based on anticipating various market trends; there is a risk that the Fund may not be invested in the best-performing markets at any particular time.

**Credit risk I** It represents the potential risk of a sudden deterioration in the quality of an issuer or its default.

## What happens if Mandarine Gestion is unable to make payments?

Mandarine Gestion is a portfolio management company approved and monitored by the Financial Markets Authority (Autorité des Marchés Financiers) and must comply with organisational and operational rules, particularly with regard to equity. The investor's funds or the income of the UCI are paid into one or more bank accounts opened in the name of the UCI. Consequently, the default of Mandarine Gestion would not have an impact on the assets of the UCI. The UCI does not benefit from a compensation scheme.

#### How much will this investment cost me?

## How long do I have to keep it and can I withdraw money early?
