What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund is actively managed without reference to any benchmark aiming to achieve long-term capital growth by investing primarily in responsible companies. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. It mainly invests directly or indirectly in equities and equity-type securities (75%-100% of net assets). No more than 10% of the Sub-fund's assets will be invested in other UCIs/UCITS. The Sub-Fund may invest up to 10% of its net assets in UCITS eligible Exchange Traded Commodities (ETC) on precious metals. The Sub-fund invests without being limited to a specific industrial sector or geographical scope; a proportion of the Sub-fund's assets may be invested in Emerging Markets. The Sub-Fund will hold strictly less than 10% of receivables (such as cash, cash equivalent, money market instruments, bank deposits at sight, cash held in current accounts or any other form of receivables) at any time. The Sub-Fund may borrow on a temporary basis up to 10% of its net assets. For the purpose of efficient portfolio management, the Sub-fund may engage in securities lending - under normal circumstances, it is generally expected that the actual percentage of the assets held by the Sub-Fund that may be subject to securities lending transactions at any time range between 0 and 30%. In exceptional circumstances and exclusively on a temporary basis, such percentage may be increased up to a maximum of 100% of the Sub-Fund's net assets. The Sub-Fund may invest in derivatives traded on Regulated Markets for investment and/or hedging purposes. Such derivatives shall include, but not be limited to futures, and options on equities and equity indices. The use of the above-mentioned derivatives may result in exposure of up to 110% of the net assets of the Sub-Fund. The investor can buy or sell shares on a daily basis (Luxembourg bank business days). This Share Class does not make any distributions. The Sub-fund shall bear the costs of standard charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 4 out of 7, which is a medium risk class and poor market conditions could impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator.
