## What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Equity Sub-fund is actively managed without reference to any benchmark aiming to achieve long-term capital growth by investing primarily in responsible companies. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/ 2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. It mainly invest directly and indirectly in equities and equity-type securities (75%-100% of net assets). To a lesser extent the Sub-fund can be invested in money market instruments (including commercial papers, money market UCITS and bank deposits). No more than 10% of the Sub-fund's assets will be invested in other UCIs/UCITS. The Sub-fund invests without being limited to a specific industrial sector or geographical scope; a proportion of the Sub-fund is suitable for investors with a five year or longer investment horizon. In order to reach its objective, the Sub-fund can use derivative instruments to protect against movements in security prices and for investment purposes. The Sub-fund uses derivatives to reduce the impact of changes in currency exchange rates on the performance for this Share Class. The investor can buy or sell shares on a daily basis (Luxembourg bank business days). This Share Class does not make any distributions. The Sub-fund shall bear the costs of standard charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

**Intended Retail Investor:** This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

## What are the risks and what could I get in return?

#### (A) Summary Risk Indicator
