Product:	TKB Aktien Schweiz ESG (CHF) B (hereinafter «Product») is a unit class of the sub-fund TKB Aktien Schweiz ESG (CHF) (hereinafter «Fund»), a sub-fund of the umbrella fund TKB (CH) Fonds.

WHAT IS THIS PRODUCT?

Type:

Collective investment scheme in accordance with the Swiss Federal Act on Collective Investment Schemes (CISA). The fund's performance depends on the performance of the underlying investments, as further described in the «Objectives» section.

Term:

The term of this product is indefinite and it has no maturity date. The manufacturer may reposition the product at any time, merge it with another product or terminate it unilaterally and without notice.

Objectives:

The investment objective of the fund is mainly to achieve a long-term increase in the value of the portfolio together with an adequate income in compliance with a sustainably oriented investment policy of the asset manager. The investment objective should primarily be achieved via direct investments in equity securities of innovative and profitable companies in Switzerland.

The fund is actively managed. The investment universe for the main investments is the benchmark index; deviations from the investments and investment weightings in the benchmark index are permitted. At least 80% of the investments satisfy ESG (Environmental, Social, Governance) criteria to ensure a sustainable investment approach.

Reference index: Swiss Performance Index (SPI®)

Fund units are issued and redeemed basically on every bank business day in Switzerland.

Earnings and profits of the unit class are not distributed, but reinvested.

Thurgauer Kantonalbank, Bankplatz 1, CH - 8570 Weinfelden, was appointed as the custodian bank.

The liability of the assets of a fund within the umbrella fund for claims against the assets of another fund is excluded.

This product is suitable for investors who ...

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator

The risk indicator assumes you keep the product for 6 years.

WHAT HAPPENS IF SWISSCANTO FUND MANAGEMENT COMPANY LTD., ZURICH, IS UNABLE TO PAY OUT?

The assets of the Fund and the assets of the fund management company are held separately. Therefore, a default by the fund management company will not affect the value of your investment. If the custodian bank goes bankrupt, the Fund's assets deposited with the custodian bank will not be included in the bankruptcy estate but will be segregated for the benefit of the Fund. In such a case, the claims by the Fund against the custodian bank in the form of privileged deposits are given priority by the custodian bank, but are otherwise treated as ordinary claims in the bankruptcy proceedings.

WHAT ARE THE COSTS?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. - CHF 10 000 is invested.
- In the first year you would get back the amount that you invested (0 % annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario.
