WHAT IS THIS PRODUCT?

Objectives : The Sub-Fund aims to achieve long term capital growth by principally investing to invest in equities of healthcare and healthcare related issuers worldwide (including Emerging Markets). There is no guarantee that the Sub-Fund will achieve a positive return over this, or any other, period and you may not get back the original amount you invested. The Sub-Fund will invest, directly or indirectly, at least 80% of its net assets in equity and equity-type securities (such as depositary receipts,

The Sub-Fund will invest, directly or indirectly, at least 80% of its net assets in equity and equity-type securities (such as depositary receipts, American Depositary Receipts, Global Depositary Receipts, etc.) of issuer worldwide, including real estate investment trust ("REITs").

The Sub-Fund is not constrained as to currency of denomination (which must be freely convertible), market capitalization, industrial sector or geography. The Sub-Fund may invest up to 10% of its net assets in Money Market Instruments and up to 10% in other UCITS or Other Undertakings for

The Sub-Fund may invest up to 10% of its net assets in Money Market Instruments and up to 10% in other UCITS or Other Undertakings for collective investment (UCIs) (whether or not they are exchange traded), provided that such UCITS or other collective investment funds which principally invest in the types of instruments mentioned above.

More than 50% of the asset value of each Sub-Fund will be invested on an ongoing basis in equity participations.

For hedging and investment purposes, the Sub-Fund may use all types of financial derivative instruments traded on a Regulated Market and/or OTC (Over the Counter).

On a temporary basis and for defensive purposes, the Sub-Fund may also hold up to 100% of its net assets in liquid assets.



HOW LONG SHOULD I HOLD IT AND CAN I TAKE MY MONEY OUT EARLY?

The recommended minimum holding period: 5 years.
