## What is this product?

### Type

The product is a share of the Global Conservative sub-fund (the “sub-fund”) which is part of Popso (Suisse) Investment Fund SICAV (the “umbrella fund”), a “société d’investissement à capital variable” (SICAV) and authorised as an undertaking for collective investment in transferable securities (UCITS) under Part I of the Law of 17 December 2010 on undertakings for collective investment (the “Law of 2010”).

### Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

The objective of the sub-fund (hereinafter, the “Fund”) is to generate a positive return in proportion to the risks of the investment strategy. In order to do so, the Fund invests in equities and bonds from around the world.

#### Investment Policy

The Fund may invest up to 40% of its assets directly or indirectly in equities and/or securities whose underlying instruments consist of equities, share certificates or similar securities provided that they are listed on a regulated market and/or an official stock exchange.

The Fund may invest in bonds, convertible bonds and money market instruments. The Fund may specifically invest in debt securities of emerging countries and up to 49% of its assets in non-investment grade debt securities. The Fund may also invest in liquid instruments and their equivalents.

The Fund may also invest in exchange traded commodities (ETC) and exchange traded notes (ETN) on commodities (up to 10% of the Fund's assets)

The Fund may use complex financial instruments (e.g. derivatives). It may also invest up to 10% of its assets in other regulated investment funds.

The fund's investment allocation is determined according to a composite benchmark index which corresponds to 75% Bloomberg Barclays Euro-Aggregate 1-7 Years Total Return Index Unhedged EUR, 10% S&P 500 Net Total Return Index, 10% EURO STOXX 50 Net Return EUR, 5% MSCI Emerging Markets Net Total Return USD Index. Since it has freedom of action when selecting and weighting investments, this fund is actively managed.

#### Share Class Policy:

Income is reinvested in the share class.

The share class is denominated in CHF. It is hedged against the base currency of the Fund.

The Fund offers several share classes. These can differ in terms of commissions, minimum investment, use of income and investor qualification.

#### Processing of subscription and redemption orders

Investors may buy or sell the Fund on any bank working day in Luxembourg.

### Intended retail Investor

The fund is intended for retail and professional clients and eligible counterparties, who are seeking to build up capital across various categories and who have a medium-term investment horizon. This fund is intended for investors with some basic knowledge or experience of financial products. Investors should be able to bear financial losses and should not require any capital guarantees.

## What are the risks and what could I get in return?

## Risk Indicator

The risk indicator assumes you keep the product for 4 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose

money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

## What happens if Carne Global Fund Managers (Luxembourg) S.A. is unable to pay out?

The assets and liabilities of the Sub-fund are segregated from those of the other sub-funds and from those of the manufacturer or the custodian. If the SICAV is not able to pay you out what is due, you may lose your entire investment. No investor guarantee nor compensation scheme is foreseen in that eventuality.

## What are the costs?

## Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario

## How long should I hold it and can I take money out early?

### Recommended holding period: 4 years
