## What is this product?

### Type

The product is a unit of the sub-fund Julius Baer Fixed Income Emerging Markets Corporate (the sub-fund) of Multicooperation SICAV (the "Umbrella Fund"), a "société d'investissement à capital variable" (SICAV) and is authorised as an undertaking for collective investment in transferable securities (UCITS) in accordance with Part I of the Law of 17 December 2010 on undertakings for collective investment (the "Law of 2010").

### Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

### Objectives

#### Investment Objective

The aim of the sub-fund ("Fund") is to generate the highest-possible return. For this purpose, the Fund invests in selected debt securities of issuers from emerging countries denominated in hard currencies.

#### Investment Policy

The Fund invests at least 2/3 of its assets in first-class debt securities and other interest-bearing assets of all types, issued or guaranteed by issuers with their head office or the majority of their business operations in emerging countries denominated in the following currencies: USD, EUR, CHF, GBP, JPY, SEK, NOK, CAD, AUD, NZD.

The Fund may invest in floating and fixed-rate debt securities issued by governments, international organisations and companies. Equally, the Fund may invest in debt securities that can be converted into shares.

The Fund may also invest up to 1/3 of its assets in other debt securities, shares, money market instruments, bank deposits as well as in target funds (less than 10%) and structured products (less than 10%).

The Fund may, under certain circumstances and by way of exception to the 2/3 rule, hold up 49% of the assets in liquid instruments.

The Fund may use complex financial instruments (e.g. derivatives) to hedge its assets against currency risks, as well as for efficient portfolio management and investment purposes.

The Fund is actively managed and does not follow any benchmark index. It has freedom of choice concerning investments and their weighting.

#### Share Class Policy:

Any income arising from this Share Class will be accumulated. Other share classes of the Fund may distribute income.

The Fund has several share classes. These may differ with regard to fees, minimum investment, use of revenues and investor qualification.

#### Processing of subscription and redemption orders

Investors may buy or sell the Fund on any bank working day in Luxembourg.

### Intended retail Investor

This Fund is aimed at retail and professional clients and eligible counterparties, who are seeking capital accumulation across categories and have a short-term investment horizon. This Fund is aimed at investors with basic knowledge or experience of financial products. The investor is prepared to bear financial losses and does not require any capital guarantees.

## What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 3 years.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

## What happens if Carne Global Fund Managers (Luxembourg) S.A. is unable to pay out?

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
