What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.


Objectives: The Sub-fund is actively managed without reference to any benchmark aiming to generate the highest possible current income in US dollars, while taking due account of the principle of risk diversification, the security of the capital invested, and the liquidity of the assets. To reach its objective, the Sub-fund invests predominantly directly and via collective investment schemes in securities and instruments with fixed and variable interest rates classified as bonds and money market instruments. Up to 20% of the Sub-fund net assets may be invested directly and via collective investment schemes in CoCos. In addition, the Sub-fund might invest via collective investment schemes in ABS, MBS and CDOs (up to 10%). The Sub-fund may invest in both investment-grade bonds and high-yield bonds, whereby no more than 49% of the Sub-fund's net assets are rated below investment grade (lowest rating from Moody's, Standard & Poor's and Fitch) or have no rating. Up to 20% of the Sub-fund's net asset value may be held in anicilary liquid assets, such as bank deposits or money market instruments. The Sub-fund is not limited to a certain currency, sector or geographical scope, although investments in emerging markets will not exceed 20% of its net assets. In addition, the Sub-fund might also invest in structured products (up to 20%). No more than 49% of Sub-fund's net assets may be invest in Target Funds. In order to reach its objective, the Sub-fund can use derivative instruments for the purposes of hedging, efficient portfolio management and implementing its investment strategy. The investor can buy or sell shares of the Sub-fund on a daily basis, as further defined in the prospectus. This Share Class does not make distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator





The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets.
