# What is this product?

## Туре

The Product is a share of the Sub-fund Emcore Precious Metal Dynamic Fund (the sub-fund) which is part of the Multibrand SICAV-SIF (the "Umbrella Fund"), a "société d'investissement à capital variable" (SICAV) and authorised as an undertaking for collective investments (UCI) under Part II of the law dated 17 December 2010 on UCIs (the "2010 Law"). The Company qualifies as an alternative investment fund ("AIF") under the Law of July 12, 2013, that implements the EU Directive 2011/61/EU on Alternative Investment Fund Managers ("AIFM Directive") into Luxembourg law (the "AIFM Law").

#### Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

## **Objectives**

#### **Investment Objective**

The investment objective of the fund is to achieve longterm capital growth by investing the assets in a portfolio of carefully selected shares and other equity securities, as well as warrants/options on shares and other equity securities of companies from the Precious metals industry sector.

#### **Investment Policy**

This sector includes companies that focus their activities on the exploration, production, processing and trading of gold, primarily, and subsidiarily, of precious metals. Furthermore the fund may invest in other equity securities, as well as warrants/options on shares and other equity securities of companies from other sectors, or in fixed-interest or floating-rate securities,
