#### **Investment Objective**

JSS Sustainable Multi Asset – Global Income (the "Sub-Fund") seeks long term capital growth by investing in various asset classes with a flexible asset allocation approach.

#### **Investment Policy**

The assets of the Sub-Fund are invested worldwide primarily in equities (min. 25%) and fixed income and money market instruments. The Sub-Fund may also invest part of its assets in convertible bonds and bonds with warrants, fixed or floating rate securities (including zero bonds) as well as in warrants and comparable assets.

Direct investments in equity securities are at least 25% of the Sub-Fund's asset, but exposure towards equity securities can be reduced to minimal 10% of the Sub-Fund's asset using the investment techniques and instruments described in section 3.4 of the prospectus.

The Sub-Fund may invest its net assets in UCITS/UCIs in accordance with the information contained in section 3.3 "Investment restrictions" of the prospectus.
