The Fund is established for an indefinite period (open-ended fund) and can be terminated at any time as further stipulated in the articles of association of the SICAV. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives

Investment Objective

The investment objective of JSS Responsible Equity – India (the "Sub-Fund") is to achieve long-term capital growth by investing in companies in India considering ESG criteria and other investments permitted under the investment policy.

Investment Policy

The assets of the Sub-Fund are mainly invested either directly (min. 67% of the Sub-Funds assets) or indirectly in all forms of equity securities (such as ordinary and preference shares, depositary receipts, etc.) domiciled in India, or whose business activities are concentrated in India or, in the case of holding companies, that are invested mainly in shares of companies domiciled in India.

The Sub-Fund promotes environmental and social characteristics according to SFDR Art. 8, but does not have a sustainable investment objective according to SFDR Art. 9. For further information of the Sub-Fund under the SFDR, investors are referred to the SCHEDULE V "SFDR Disclosures". The Sub-Fund is actively managed without replicating any benchmark. However, the Sub-Fund is managed with reference to MSCI India NR Index

(the "Benchmark"). Generally, the majority of the positions within the Sub-Fund are constituents of the Benchmark. In order to exploit specific investment opportunities the Investment Manager may discretionarily select securities not included in the Benchmark. In addition, the Investment Manager integrates sustainable aspects which lead to an exclusion of investable Benchmark components. The holdings and their weightings in the Sub-Fund's portfolio will diverge from the weightings of the securities included in the Benchmark therefore the Sub-Fund's returns may deviate from the performance of the Benchmark.

Share Class Policy:

This share class of the Sub-Fund continually reinvests income.

Processing of subscription and redemption orders

You may subscribe, redeem or convert shares in the Sub-Fund on any business day. Subscription and and redemption orders must be received by the transfer agent in Luxembourg at the latest one (1) Business Days before the Valuation Day, no later than 12.00 (noon) Luxembourg time. The Sub-Fund is suitable for investors with a medium to long-term investment horizon who are aiming for asset growth. As a supplementary investment in the equities segment, the Sub-Fund is aimed for investors with a medium to high risk tolerance.
