WHAT IS THIS PRODUCT?

Type

Pictet CH - CHF Bonds Tracker is a subfund of an open-ended contractual investment fund with segregated liability between subfunds and is authorised as an other fund for traditional investment in Switzerland.

Term

This product has no maturity date. The Fund has been established for an indefinite period. However, it may be wound up at any time by the Management Company or the custodian bank. Dividend distribution policy: Accumulated. You may redeem your investment upon demand. Dealing frequency: Daily.

Objectives

To replicate a performance comparable to the benchmark.

Reference Index

Swiss Bond Index AAA-BBB, an index that does not take into account environmental, social and governance (ESG) factors.

Portfolio Assets

The fund invests in Swiss franc-denominated bonds included in the benchmark.

Derivatives and Structured Products

The fund may use derivatives to reduce various risks (hedging) and portfolio management costs, as well as to increase its exposure to certain assets.

Compartment Currency

Investment Process

For passive management of the fund, the manager aims to minimize the difference between the portfolio's performance and that of the benchmark by using an optimized sampling method (creating a portfolio of assets with characteristics similar, but not always identical, to the benchmark). The fund is not sustainably managed; the manager is likely to invest in issuers with low ESG profiles. However, it is working to influence societies on material issues of sustainability. The fund's investment policy is similar to that of an "Article 6" financial product according to the European Union's regulations on sustainable investment information.

Intended retail investor

Suitable for investors with all levels of knowledge and/or experience, seeking capital growth, and income distribution, and who have an investment horizon between 3 and 5 years. The product does not have any capital guarantee and up to 100% of their capital is at risk.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk Indicator





The risk indicator assumes you keep the product for 3 year(s).

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

WHAT HAPPENS IF PICTET ASSET MANAGEMENT S.A. IS UNABLE TO PAY OUT?

The product is not covered by any deposit protection scheme. However, the management company is mandated by law to hold the assets of the Fund with the custodian bank and keep them separate from its own assets. A default of Pictet Asset Management S.A. will therefore have no impact on the value of your investment in the product.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- CHF 10,000 is invested.
