## WHAT IS THIS PRODUCT?

### Type

Pictet CH - Sovereign Short-Term Money Market CHF is a contractual investment fund and is authorised as an "other fund for traditional investments" in Switzerland.

### Term

This product has no maturity date. The Fund has been established for an indefinite period. However, it may be wound up at any time by the Fund Management or the custodian bank. Dividend distribution policy: Distributed. You may redeem your investment upon demand. Dealing frequency: Daily.

### Objectives

Generate a stable return and preserve the value of your investment, while taking into account environmental, social and governance (ESG) criteria.

### Reference Index

The fund is managed without reference to an index.

### Portfolio Assets

The fund invests primarily in government instruments and highly rated short maturity government bonds. These investments are denominated or hedged in Swiss francs so that the exchange rate risk is non-existent or limited.

### Derivatives and Structured Products

The fund may use derivatives to reduce various risks (hedging), but not to reduce portfolio management costs or increase exposure to certain assets.

### Investment Process

To actively manage the fund, the investment manager uses market, interest rate and credit risk analysis to select securities that it believes offer the best risk-adjusted returns. The manager constructs its portfolio in accordance with Pictet Asset Management's responsible investment principles. It mainly selects investments with a high ESG profile. The fund's investment policy is similar to that of an Article 8" financial product according to the European Union's regulations on sustainable investment information."

### Intended retail investor

Suitable for investors with all levels of knowledge and/or experience, seeking capital preservation, capital growth, and income distribution, and who have an investment horizon of 1 month. The product does not have any capital guarantee and up to 100% of their capital is at risk.

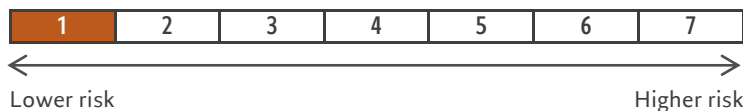

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk Indicator



The risk indicator assumes you keep the product for 1 month.  
The actual risk can vary significantly if you cash in at an early stage and you may get back less.

### WHAT HAPPENS IF PICTET ASSET MANAGEMENT S.A. IS UNABLE TO PAY OUT?

The product is not covered by any deposit protection scheme. However, the Fund Management is mandated by law to hold the assets of the Fund with the custodian bank and keep them separate from its own assets. A default of Pictet Asset Management S.A. will therefore have no impact on the value of your investment in the product.

### WHAT ARE THE COSTS?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario

- CHF 10,000 is invested.
