WHAT IS THIS PRODUCT?

Pictet - Climate Government Bonds is a Fund of an open-ended investment company with variable capital ("SICAV") with segregated liability between Funds and is authorised as an Undertaking for Collective Investment Transferable Securities ("UCITS") in Luxembourg.

Term

This product has no maturity date. The Fund is formed for an indefinite period. However, the Board of Directors may in certain cases decide to close the Fund or at any time propose to close the Fund at an extraordinary general Shareholders' meeting. Dividend distribution policy: Accumulated. You may redeem your investment upon demand. Dealing frequency: Daily.

Objectives

To increase the value of your investment, through income and investment growth. A sustainable strategy of low carbon emission exposure in view of achieving the objectives of the Paris Agreement is also applied.

Reference Index

Portfolio Assets

The Fund mainly invests in government bonds issued by countries that are reducing their greenhouse gas emissions and carbon intensity (net of land and forestry management) or in the opinion of the Investment Manager are in the process of implementing policies that may lead to a meaningful improvement. The Fund may invest worldwide, including in emerging markets and Mainland China, and can invest across any currency. These may include Sharia-compliant bonds. Some of these investments may be below investment grade.

Derivatives and Structured Products

The Fund may use derivatives to reduce various risks (hedging) and for efficient portfolio management, and may use derivatives and structured products to gain exposure to portfolio assets.

Investment Process

In actively managing the Fund, the Investment Manager selects countries based on their carbon emissions reduction and following uses a combination of macroeconomic, market and issuer analysis to build a diversified portfolio of securities it believes offer the best risk-adjusted returns. The Fund's management approach uses strict risk controls. There may be engagement with countries to positively influence climate related matters. The performance of the Fund is likely to be significantly different from that of the benchmark, because the Investment Manager has significant discretion to deviate from its securities and weightings.

WHAT HAPPENS IF PICTET ASSET MANAGEMENT (EUROPE) S.A. IS UNABLE TO PAY OUT?

Pictet Asset Management (Europe) S.A. is a société anonyme. The SICAV is also a société anonyme and its assets are segregated from those of the Management Company. The SICAV has entrusted the Depositary Bank with the safekeeping of its assets, which are kept separated from the Depositary Bank's assets. A default of Pictet Asset Management (Europe) S.A. will therefore have no impact on the value of your investment in the product. However, you may benefit from a consumer protection scheme.

WHAT ARE THE COSTS?

Costs over Time
