WHAT IS THIS PRODUCT?

Туре

Pictet - Short-Term Money Market EUR is a Fund of an open-ended investment company with variable capital ("SICAV") with segregated liability between Funds and is authorised as an Undertaking for Collective Investment Transferable Securities ("UCITS") in Luxembourg.

Term

This product has no maturity date. The Fund is formed for an indefinite period. However, the Board of Directors may in certain cases decide to close the Fund or at any time propose to close the Fund at an extraordinary general Shareholders' meeting. Dividend distribution policy: Accumulated. You may redeem your investment upon demand. Dealing frequency: Daily.

Objectives

To preserve the value of your investment, while achieving a return in line with money market rates.

Reference Index

FTSE EUR 1-Month Eurodeposit (EUR), an index that does not take into account environmental, social and governance (ESG) factors. Used for performance measurement.

Portfolio Assets

The Fund mainly invests in short-term money market instruments that are issued by highly rated issuers and are either denominated in Euro (EUR) or systematically hedged to this currency (meaning investments have little or no exposure to currency risk).

Derivatives and Structured Products

The Fund may use derivatives to reduce various risks (hedging).

Investment Process

In actively managing the Fund, the Investment Manager uses a combination of market and issuer analysis to identify those securities that offer the best performance in light of interest rate trends. The Fund's management approach uses strict risk controls. The Investment Manager considers ESG factors a core element of its strategy by adopting a tilted approach which seeks to increase the weight of securities with low sustainability risks and/or to decrease the weight of securities with high sustainability risks, subject to good governance practices. Activities that adversely affect society or the environment are also avoided. There may be engagement with companies to positively influence ESG practices. The portfolio composition is not constrained relative to the benchmark, so the similarity of the Fund's performance to that of the benchmark may vary.

The risk indicator assumes you keep the product for 1 month.

WHAT HAPPENS IF PICTET ASSET MANAGEMENT (EUROPE) S.A. IS UNABLE TO PAY OUT?

Pictet Asset Management (Europe) S.A. is a société anonyme. The SICAV is also a société anonyme and its assets are segregated from those of the Management Company. The SICAV has entrusted the Depositary Bank with the safekeeping of its assets, which are kept separated from the Depositary Bank's assets. A default of Pictet Asset Management (Europe) S.A. will therefore have no impact on the value of your investment in the product. However, you may benefit from a consumer protection scheme.

WHAT ARE THE COSTS?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario - EUR 10,000 is invested.
