# WHAT IS THIS PRODUCT?

#### Type

Pictet - Sovereign Short-Term Money Market USD is a Fund of an open-ended investment company with variable capital ("SICAV") with segregated liability between Funds and is authorised as an Undertaking for Collective Investment Transferable Securities ("UCITS") in Luxembourg.

#### Term

This product has no maturity date. The Fund is formed for an indefinite period. However, the Board of Directors may in certain cases decide to close the Fund or at any time propose to close the Fund at an extraordinary general Shareholders' meeting. Dividend distribution policy: Accumulated. You may redeem your investment upon demand. Dealing frequency: Daily.

## **Objectives**

To preserve the value of your investment, while achieving a return in line with money market rates.

# Portfolio Assets

The Fund mainly invests in deposits and in short-term, highly rated investment-grade money market instruments that are either denominated in US dollar (USD) or systematically hedged to this currency (meaning investments have little or no exposure to currency risk). These are issued by governments or public organisations in developed countries.

# Derivatives and Structured Products

The Fund may use derivatives to reduce various risks (hedging).

### **Investment Process**

In actively managing the Fund, the Investment Manager uses a combination of market and issuer analysis to identify those securities that offer the best performance in light of interest rate trends. The Fund's management approach uses strict risk controls. The Investment Manager considers ESG factors a core element of its strategy by adopting a best in class approach which seeks to invest in securities of issuers with low sustainability risks while avoiding those with high sustainability risks, subject to good governance practices. Activities that adversely affect society or the environment are also avoided. There may be engagement with companies to positively influence ESG practices. The portfolio composition is not constrained relative to the benchmark, so the similarity of the Fund's performance to that of the benchmark may vary.



#### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### **Risk Indicator**





The risk indicator assumes you keep the product for 1 month.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

#### **Performance Scenarios**

#### WHAT HAPPENS IF PICTET ASSET MANAGEMENT (EUROPE) S.A. IS UNABLE TO PAY OUT?

Pictet Asset Management (Europe) S.A. is a société anonyme. The SICAV is also a société anonyme and its assets are segregated from those of the Management Company. The SICAV has entrusted the Depositary Bank with the safekeeping of its assets, which are kept separated from the Depositary Bank's assets. A default of Pictet Asset Management (Europe) S.A. will therefore have no impact on the value of your investment in the product. However, you may benefit from a consumer protection scheme.

## WHAT ARE THE COSTS?

## **Costs over Time**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario

- USD 10,000 is invested.
