WHAT IS THIS PRODUCT?

Type

Pictet CH Precious Metals Fund - Physical Gold is a subfund of an open-ended contractual investment fund with segregated liability between subfunds and is authorised as an other fund for traditional investment in Switzerland.

Term

This product has no maturity date. The Fund has been established for an indefinite period. However, it may be wound up at any time by the Management Company or the custodian bank. Dividend distribution policy: Accumulated. You may redeem your investment upon demand. Dealing frequency: Daily.

Objectives

To increase the value of your investment over the long term by following the development of the gold price.

Reference Index

The fund is managed without reference to an index.

Portfolio Assets

The fund invests primarily in physical gold.

Derivatives and Structured Products

The fund may use derivatives only to hedge currency risks in certain unit classes.

Compartment Currency

USD

Investment Process

For passive management of the fund, the investment manager aims to minimize the difference between the portfolio's return and the price of gold. The fund is not sustainably managed. However, the manager normally only buys physical gold that has been mined in accordance with a recognized responsible gold standard. The fund's investment policy is similar to that of an "Article 6" financial product according to the European Union's regulations on sustainable investment information.

Intended retail investor

Suitable for investors with all levels of knowledge and/or experience, seeking capital growth, and who have a 5 years or more investment horizon. The product does not have any capital guarantee and up to 100% of their capital is at risk.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk Indicator





The risk indicator assumes you keep the product for 5 year(s).

WHAT HAPPENS IF PICTET ASSET MANAGEMENT S.A. IS UNABLE TO PAY OUT?

The product is not covered by any deposit protection scheme. However, the management company is mandated by law to hold the assets of the Fund with the custodian bank and keep them separate from its own assets. A default of Pictet Asset Management S.A. will therefore have no impact on the value of your investment in the product.

WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- EUR 10,000 is invested.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 5.28 % before costs and 4.83% after costs.
