# What is this product?

#### TYPE OF PRODUCT

The Fund is a sub-fund of U ACCESS, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

#### **TFRM**

The Fund is established for an unlimited duration. However the Board of Directors of the Fund may decide on its pure and simple liquidation if its net assets represent less than EUR 20 million (or equivalent value in another currency) or if the economic and/or political environment was to change or for any economic and financial reasons for which the Board of Directors considers that it is in the general best interests of shareholders to liquidate the Fund.

#### **OBJECTIVES**

The Fund seeks to grow capital and generate income by investing primarily in long and short positions on Japanese equity markets.

Long positions in companies having a good corporate governance will be achieved through direct physical holdings and/or through financial derivatives whereas short positions in companies having a lesser corporate governance will be achieved through the use of financial derivative instruments.

The Fund is actively managed and will invest in large cap equity and up to 10% in equities with a market capitalization below USD 1 billion.

The Fund will also invest in government or Investment grade corporate issuer debt securities, money market instruments and cash deposits.

The Fund is allowed to invest without limits in currencies other than its base currency (USD). These investments may or may not be hedged at the Investment Manager's discretion.

The Fund is not managed in reference to a benchmark.

The Fund may also make use of financial derivatives instruments for efficient portfolio management and hedging purposes.

Derivative instruments include, but are not limited to: Contracts for Differences (CFD), equity swaps, basket swaps, FX forwards and/or Total Return Swaps (TRS).

TRS are used as an integral part of the investment policy and on a continuous basis, regardless of market conditions, mainly for implementing components of the investment strategy to enhance returns than can only be achieved through derivatives. TRS may also be used, to a lesser extent, for implementing elements of the investment strategy for efficient portfolio management techniques such as gaining cost efficient long exposure.

The current expected proportion of assets under management for this Fund that will be subject to TRS is between 30-100% (with long exposure between 15% and 50% and short exposure between 15% and 50%).

The current maximum proportion of assets under management for this Fund that will be subject to TRS is of 230% (with long exposure 115% and short exposure 115%).

The Fund's base currency is USD.

The recommended holding period is determined to allow sufficient time for this product to reach its objectives and provide a consistent return less dependent on market fluctuations. Nevertheless, such return is not guaranteed.

The return of the product is determined using the Net Asset Value (NAV) calculated by the Administrative Agent. This return depends mainly on the market value fluctuations of the underlying investments.

The share currency risk in relation to the Fund's base currency is mainly hedged.

Any income received by the Fund is reinvested (capitalisation share).

#### INTENDED RETAIL INVESTORS

The Fund is suitable for retail investors with average knowledge of the underlying financial instruments and some financial industry experience. The Fund is also suitable for investors who may bear capital losses, who do not need capital guarantee and who wish to hold their investment over 3 years.

# What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 3 years.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level. Poor market conditions are unlikely to impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a currency other than your local currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This Fund does not include any protection from future market performance, so you could lose some or all of your investment. If the Fund is not able to pay you what is owed, you could lose your entire investment

#### Performance scenarios

# What happens if the product is unable to pay out?

There is no guarantee in place against the default of the Fund and you could lose your capital if this happens.

The Fund's assets are held with BNP Paribas S.A., Luxembourg Branch and are segregated from the assets of other sub-funds of the SICAV and from the assets of the Depositary. The assets of the Fund cannot be used to pay the debts of other sub-funds.

In the event of insolvency of the Depositary, the Fund may suffer a financial loss.

In the event of insolvency of the product manufacturer, the Fund's assets will not be affected.

### What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

#### Costs over time (\*)

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

# How long should I hold it and can I take my money out early?

### Recommended Holding Period (RHP): 3 years.

The RHP is determined to allow sufficient time for this product to reach its objectives and to provide a consistent return less dependent on market fluctuations. Investors should be prepared to remain invested for at least 3 years but can nevertheless redeem their investment at any time, or hold the latter for a longer period of time.

The Net Asset Value (NAV) is daily except if it is not a full bank business day in Luxembourg or in the United States or in the United Kingdom or in Japan (each a Business Day). The NAV is calculated the following full bank business day in Luxembourg (Calculation Day). Redemptions are possible on each NAV date. All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 13:00 (Luxembourg time) two (2) Business Days prior to the NAV Date. Redemption proceeds shall be paid within two (2) Business Days following the NAV Date.
