What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

Seeking medium/long-term capital growth through a diversified and sustainable portfolio incorporating environmental, social and governance (ESG) criteria with long exposure to equities. The focus of ESG criteria will mainly be on aspects of the energy transition and the reduction of carbon emissions. The adjacent objective is thus to contribute to promoting global climate stabilisation.

The sub-fund mainly invests, without sector restrictions, in shares of companies. The sub-fund predominantly invests in companies which are or should be able to benefit from seeking solutions in the context of the energy transition and reduction of carbon emissions.

The proportion of the sub-fund's net asset value invested in the equities market and in equity securities in the capital of any company is at least 51%.

The sub-fund may invest up to 10% of its net assets in units of UCITS or other UCIs.

The manager may use derivatives to hedge or optimise the portfolio's exposure. Furthermore, the sub-fund may hold cash on an ancillary basis.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is suitable for all types of investors with a medium-term investment horizon and at least basic knowledge of financial instruments that can withstand potential losses.

Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

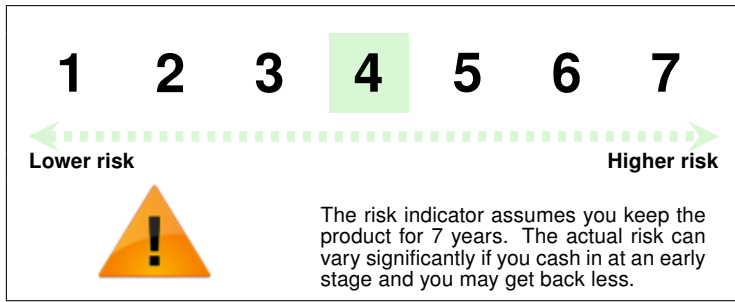

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Favourable scenario: This type of scenario occurred for an investment between December 2012 and December 2019, by referring to a benchmark.

What happens if Mediobanca Management Company S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
