## What is this product?

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

### **Objectives**

Seeking medium/long-term capital growth through a diversified and sustainable portfolio incorporating environmental, social and governance (ESG) criteria with long exposure to equities. The focus of ESG criteria will mainly be on aspects of the energy transition and the reduction of carbon emissions. The adjacent objective is thus to contribute to promoting global climate stabilisation. The sub-fund mainly invests, without sector restrictions, in shares of compa-

nies. The sub-fund predominantly invests in companies which are or should be able to benefit from seeking solutions in the context of the energy transition and

reduction of carbon emissions.

The proportion of the sub-fund's net asset value invested in the equities market and in equity securities in the capital of any company is at least 51%.

The sub-fund may invest up to 10% of its net assets in units of UCITS or other

The manager may use derivatives to hedge or optimise the portfolio's exposure. Furthermore, the sub-fund may hold cash on an ancillary basis.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

## Intended retail investor

The sub-fund is suitable for all types of investors with a medium-term investment horizon and at least basic knowledge of financial instruments that can withstand potential losses.

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.



## What are the risks and what could I get in return?

#### Risk indicator

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

## What happens if Mediobanca Management Company S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

### Costs over time
