What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the board of directors may decide to close the sub-fund under certain circumstances.

Objectives

Generate above average returns in the medium to long term by investing into debt related instruments and the majority of the returns will be derived by the yield of the underlying investments and capital gains.

The sub-fund will mainly invest in bonds and other debt related securities, primarily denominated in USD, whose issuers are domiciled in, or are exercising the predominant part of their economic activity in Asian countries. The sub-fund may invest in local markets and local currency bonds.

The sub-fund may invest up to one third in bonds and other debt related securities without any restriction as regards to region, sector or rating, and in money market instruments and any other financial instruments linked to an interest rate.

The sub-fund may invest up to 10% to the aforementioned categories indirectly through other investment funds.

The sub-fund may use derivatives in order to hedge its portfolio against the consequences of adverse market developments.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is intended for medium term retail investors with basic knowledge/experience, who can bear losses. The sub-fund can be used for general capital accumulation purposes.

Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

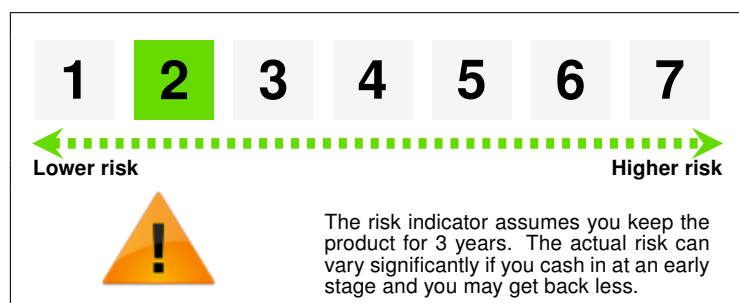

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Credit risk, Emerging markets risk

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

Unfavourable scenario: This type of scenario occurred for an investment be-

tween October 2019 and October 2022.

Moderate scenario: This type of scenario occurred for an investment between October 2016 and October 2019.

Favourable scenario: This type of scenario occurred for an investment between January 2014 and January 2017, by referring to a benchmark.

The stress scenario shows what you might get back in extreme market circumstances.

What happens if RAM (LUX) TACTICAL FUNDS II is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10.000 USD is invested

The conversion of part or all of the shares is free of charge.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

You should be prepared to stay invested for 3 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
