Purpose

LGT Sustainable Bond Fund Global Inflation Linked (the "Fund") a sub-fund of LGT Funds SICAV (the "Umbrella")

LGT Sustainable Bond Fund Global Inflation Linked (USD) A (ISIN: LI0148578003) (the "Class")

This Fund is authorised in Liechtenstein.

This Fund is managed by LGT Capital Partners (FL) Ltd (the "Management Company"), which is authorised in Liechtenstein and regulated by the Liechtenstein Financial Market Authority (FMA). The Liechtenstein Financial Market Authority (FMA) is responsible for supervising LGT Capital Partners (FL) Ltd in relation to this Key Information Document. What is this product?

Type: This product is a sub-fund of an investment company with variable capital established under the laws of Liechtenstein as an undertaking for collective investment in transferable securities ("UCITS").

Term: The product does not have a pre-defined maturity and it is an open-ended structure.

The Fund may be liquidated by the Management Company in certain circumstances, as described further in the Prospectus of the Umbrella.

Objectives

The objective of this Fund is to achieve reasonable capital growth that is protected against inflation.

The Fund will seek to achieve this by investing primarily in inflation-linked, interest-bearing debt securities or equivalent securities issued by private or public borrowers.

Synthetic structures (i.e. through derivatives) may be utilised in order to achieve a broader diversification across debtors, a more flexible maturity management and protection against inflationary risks in markets without inflation-linked, interest-bearing debt securities.

The Fund may invest in derivatives (financial instruments derived from other securities or assets) for hedging purposes, efficient portfolio management and / or investment purposes.

The Fund is actively managed in reference to its benchmark, the Bloomberg World Government Inflation-Linked Bonds 1 to 10 Year TR "hedged" Index (the "Benchmark"), by virtue of the fact that the investment manager uses the Benchmark to provide a framework for the Fund's main investable universe, for risk measurement metrics and for performance comparison purposes. A proportion of the Fund's portfolio, such proportion to be defined by the investment manager from time to time, may be components of the Benchmark and the portfolio may have similar weightings to the Benchmark, however, the investment manager retains full discretion over the composition of the portfolio subject to the investment restrictions specified in the prospectus. Accordingly, the Fund may, at the investment manager's discretion, be invested in markets and constituents not referenced in the Benchmark to the extent and within such constraints as the investment manager determines appropriate.

Environmental, social and governance ("ESG") aspects are considered as part of the Fund's investment process.

The Fund may have positions in cash and cash equivalents.

The portfolio transaction costs may have a material impact on performance.

Investors may on a daily basis subscribe for shares of the Fund and may on a daily basis redeem shares of the Fund.

Any income generated by the Class is distributed.

Intended retail investor: Investment in the Fund is suitable for investors with basic knowledge about the fixed income instruments contained in the Fund. An investment horizon of 3 years is recommended and the ability to bear low investment losses. There is a risk of losing the full capital invested.



This Key Information Document describes a sub-fund of the Umbrella. The prospectus and the periodic reports are prepared for the entire Umbrella named at the beginning of the Key Information Document.

The Fund is a sub-fund of the Umbrella with segregated liability between sub-funds. This means that the holdings of the Fund are maintained separately from the holdings of other sub-funds of the Umbrella and your investment in the Fund will not be affected by claims against any other sub-fund of the Umbrella.

Conversion of shares: You do not have the right to convert your shares in this Fund into shares of another sub-fund of the Umbrella.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This classification rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

What happens if LGT Capital Partners (FL) Ltd is unable to pay out?

The assets of the Fund are held in safekeeping by LGT Bank Ltd (the "Depositary"). In the event of the insolvency of LGT Capital Partners (FL) Ltd (the "Management Company"), the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. There is no investor compensation or guarantee scheme in the case of default of the Management Company or the Depositary.

What are the costs?

Costs over time
