## What is this product?

### Type

CT (Lux) Responsible Euro Corporate Bond (the "Fund") is a sub-fund of Columbia Threadneedle (Lux) III (the "SICAV"), an open-ended investment fund with variable capital. The SICAV is authorised under Luxembourg law and qualifies as an UCITS.

### Term

The Fund does not have a maturity date. The Directors of the SICAV may decide to unilaterally liquidate the Fund with notice to the investors. Please refer to the Prospectus for more information.

### Objectives

The objective is to achieve an above average rate of return over the long term measured in Euro. The Fund invests only in assets which meet the Fund's predefined ethical and environmental, social and governance (ESG) screening criteria.

The Fund seeks to achieve this by investing mainly in investment grade, Baa3/BBB- or higher rated (by Moody's, Standard & Poor's or another recognised credit rating agency), debt securities (fixed and variable income paying bonds) issued by companies, including asset backed and contingent convertible (bonds that can be converted into a predetermined amount of the company's equity at certain times during its life, usually at the discretion of the bondholder) securities.

The Fund may also invest up to 15% in sub-investment grade debt securities, those rated Ba1/BB+ or lower, and up to 10% each in asset backed securities and contingent convertible bonds.

The Fund is permitted to deal in derivative contracts for hedging and efficient portfolio management purposes.

The Fund is actively managed. The Manager believes that an appropriate comparator benchmark for reviewing fund performance is the BBI Euro Aggregate Corporate TR Index, given the investment policy of the Fund and the approach taken by the manager. The Fund is not constrained by this benchmark and has significant freedom to invest in a portfolio that is materially different to the benchmark's own composition. With regard to the Fund's screening criteria, the Fund will:

- invest in companies that demonstrate responsible business practices;
- avoid investments in companies with activities that harm society or the environment; and
- use its influence as an investor to encourage companies to improve their management practices through engagement.

There is no minimum holding period for this Fund. However, it may not be appropriate for investors who plan to withdraw their money in under 3 years.

Income from investments in the Fund will be added to the value of your shares.

### Intended retail investor

This Fund is intended for investors who should have at least a basic level of knowledge and experience of investing in funds. It is designed for investors looking for income and capital growth and an investment that promotes environmental and social characteristics, who can invest their money for at least 5 years. Your capital is not guaranteed which means that investors could lose up to 100% of the amount invested. The fund invests directly and through derivatives in fixed income securities which tend to have a higher risk profile than money market securities due to higher company specific credit and interest rate risk but a lower risk profile than equity markets.

## What are the risks and what could I get in return?

### RISK INDICATOR



The risk indicator assumes you keep the product for 3 year(s).

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the value of your investment.

### Performance scenarios

## What happens if Carne Global Fund Managers is unable to pay out?

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
- EUR 10,000 is invested.

There is no minimum or maximum holding period and you can redeem your shares without penalty on any Luxembourg Business Day. Your return may be negatively impacted if you redeem your shares prior to the recommended holding period.
