# What is this product?

#### Туре

The product is a unit of the sub-fund Obligationen EUR (the sub-fund), which is part of SGKB (Lux) Fund (the "Umbrella Fund"), a specialised investment fund (SIF-fonds d'investissement spécialisé) in the form of an investment fund (FCP) (fonds commun de placement), which is established in accordance with the Luxembourg Law of 13 February 2007 on specialised investment funds, as amended (the "SIF Law").

#### Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

## Objectives

#### **Investment Objective**

The aim of the sub-fund ("Fund") is to achieve steady capital growth over the long term by means of a conservative risk strategy. For this purpose, the Fund invests in first-class debt securities which are denominated in euros (EUR). These are investments which are extremely likely to be repaid in full on maturity and to pay interest on time and in full.

#### **Investment Policy**

The Fund invests at least 2/3 of its assets in floating and fixed-rate debt securities which are denominated in euros (EUR) and are issued or guaranteed by governments, international organisations and companies. The Fund is also free to invest in debt securities that can be converted into or exchanged for shares.

The Fund may use complex financial instruments to hedge the Fund assets and to profit from promising investments.

The Fund is actively managed. It follows the benchmark JPM GBI EMU ex GR / IE / IT / PT / ES 1-10Y, which it seeks to outperform over the long term.

Unless otherwise defined in this document, all words and expressions defined in the Fund's current prospectus shall have the same meaning herein.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.
