### WHAT IS THIS PRODUCT?

**Type:** Impax Asian Environmental Markets (Ireland) Fund (the "Fund") is a sub-fund of Impax Funds (Ireland) plc, an open-ended investment company with variable capital incorporated in Ireland with registered number 393658. 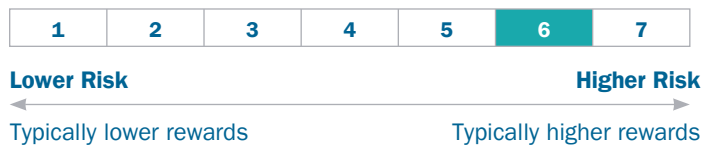

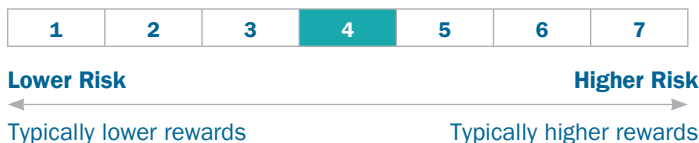
