WHAT IS THIS PRODUCT?

Type: Impax US Environmental Leaders Fund (the "Fund") is a sub-fund of Impax Funds (Ireland) plc, an open-ended investment company with variable capital incorporated in Ireland with registered number 393658 and authorised by the Central Bank of Ireland as an umbrella fund with segregated liability between sub-funds and as an undertaking for collective investment in transferable securities pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended. Segregated liability between sub-funds means that the assets and liabilities of each sub-fund are segregated by law. The prospectus and periodic reports are prepared for Impax Funds (Ireland) plc at umbrella level. You may switch your shares in the Fund to shares in other sub-funds in which you are eligible to invest. Objectives: The Fund seeks to generate long term capital growth through an actively managed portfolio of equities traded on US exchanges. The Fund aims to enable investors to benefit from growth anticipated in environmental markets, through a portfolio of companies providing solutions to local and global environmental pollution and improving efficient use of finite natural resources. The Fund provides disclosures in accordance with Article 9 of Regulation (EU) 2019/2088 ("SFDR").

The Fund pursues its objectives through a classification system developed in-house, which seeks to identify companies providing environmental solutions in response to multi-year thematic trends e.g., growing populations, rising living standards, increasing urbanisation, rising consumption, depletion of limited natural resources and climate change. 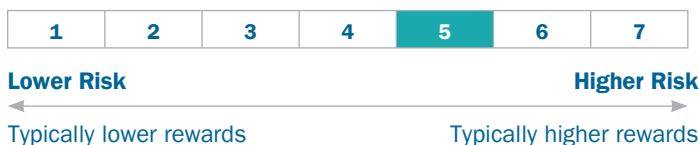
