What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Sub-fund is actively managed without reference to any benchmark aiming to achieve absolute returns over the medium term. In order to achieve its objective, the Sub-fund mainly invests and trades in equity markets by taking long positions in equities and bonds and long and short positions in exchange-traded and/or over-the-counter (OTC) financial derivative instruments (FDI) such as, but not limited to futures, options and swaps. To a lesser extent, it may hold liquid assets and deposits or invest in money market instruments with maturities not exceeding 12 months. The Sub-fund can invest worldwide, however the geographical scope will be on European companies. In addition to its investment policy, the Sub-fund may also use FDIs to protect against movements in currencies and security prices. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. This share class does not make regular distributions. The investors can buy or sell shares on weekly basis.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 3 out of 7, which is a medium-low risk class and poor market conditions are unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product.
