## What is the product?

**Type:** This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Sub-fund is actively managed without reference to any benchmark. The investment objective of the Sub-fund is to generate absolute returns over the medium to long term. The Sub-fund invest primarily by taking both long and short investment positions in equity and equity-related securities. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Sub-fund is not limited to a certain currency, sector or geographical scope, however investments in the Europe will account for a larger proportion than investments in other markets. The investments in emerging markets will not exceed 10% of its net assets. Additionally the Sub-fund may be exposed to other collective investment schemes, exchange-traded funds and over the counter Foreign Direct Investment ("FDI"), short duration fixed-income instruments (fixed or floating rate, investment grade bonds). In addition to this the Sub-fund may invest substantially in cash deposits, cash equivalents, certificates of deposits and/or Money Market Instruments. The Sub-fund uses derivatives to reduce the impact of changes in currency exchange rates on the performance for this Share Class. The Sub-fund may also use financial derivative instruments such as but not limited to forward, futures, options, swaps and Contracts for Difference ("CFDs"). In case of investments in Total Return Swaps, the maximum leveraged value of the investments might reach up to 100% of the Sub-fund's net assets. This share class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

**Intended Retail Investor:** This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

## What are the risks and what could I get in return?

### (A) Summary Risk Indicator



**The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.**

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 4 out of 7, which is a medium risk class and poor market conditions could impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies.
