## What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** The Sub-fund is actively managed without reference to a benchmark aiming to achieve risk-adjusted returns by investing in worldwide Cat Bonds and bonds. The Sub-fund promotes environmental, social and governance (ESG) characteristics within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Sub-fund invests worldwide and in any currency in Cat Bonds (a minimum of 70% of its Net Asset Value) and in diversified range of bonds, floating and/or fixed, issued by governments, institutions and corporations (up to 30% of its Net Asset Value). The Sub-fund may invest up to 20% of its Net Asset Value in EUR denominated bonds. Investments of the Sub-fund may be made indirectly via collective investment schemes (up to 10%). For liquidity management purposes, the Sub-fund may invest up to 100% of its Net Asset Value in short-term liquid investments, including cash and money market instruments. In order to reach its objective, the Sub-fund can use derivative instruments for the purpose of hedging and efficient portfolio management. In addition, the Sub-fund might also invest in structured products. The Sub-fund will predominantly hold bonds with investment grade ratings (Baa3 or above by Moody's or BBB or above by Standard and Poor's or equivalent credit ratings). Investments below this grade may be held up to 5% of the Net Asset Value of the Sub-fund. The Hurdle Rate Index used to calculate the performance fee will depend on the reference currency of the relevant share class as follows: USD: SOFR + 2% p.a., EUR:  $\in$ STR + 2% p.a., CHF: SARON + 2% p.a., GBP: SONIA + 2% p.a., AUD: AONIA + 2% p.a., SEK: STIBOR + 2% p.a. The investor can buy or sell shares of the Sub-fund on a weekly basis, as further defined in the prospectus. This Share Class makes regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred

#### (A) Summary Risk Indicator
