## What is the product?

Type: This Product is a common fund qualifying as UCITS Sub-fund in accordance with the UCITS law.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Management Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund invests its assets mainly in fixed income securities (debt instruments, bonds, notes, similar fixed-interest or floating-rate securities (including securities issued on a discount basis)) with a short to medium term maturity of corporate issuers worldwide which have a minimum credit rating of BBB- (Standard & Poor's) or Baa3 (Moody's). Investments in fixed income securities of issuers denominated in CHF will account for a larger proportion than investments in fixed income securities in other currencies. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of exclusions, ESG integration and active ownership. The most material ESG factors are combined with traditional financial analysis to calculate an ESG integrated credit rating, which serves as the basis for a bottom-up security selection process. This Sub-fund aims to outperform the return of the SBI AAA-BBB 1-3Y benchmark. The Sub-fund is actively managed. The benchmark has been selected because it is representative of the investment universe of the Sub-fund and it is therefore an appropriate performance comparator. The majority of the Sub-funds' exposure to bonds will not necessarily be components of, or have weightings derived from, the benchmark. The Investment Manager will use its discretion to significantly deviate the weighting of certain components of the benchmark and to significantly invest in bonds not included in the benchmark in order to take advantage of specific investment opportunities. It is thus expected that the performance of the Sub-fund will significantly deviate from the benchmark. The Sub-fund may use derivatives to achieve the above aims. The investor can buy or sell units of the Sub-fund on a daily basis, as further defined in the prospectus. This Unit Class does not make distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securit

## What are the risks and what could I get in return?

#### (A) Summary Risk Indicator
