What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund invests at least two-thirds of its assets in equities and equity-type securities of companies which are directly or indirectly owned, controlled and/or managed by entrepreneurs and/or families who are represented in the shareholders' capital with at least 10% of voting rights and have their registered office or carry out the majority of their economic activity in countries of the European Monetary Union. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of exclusions, ESG integration and active ownership.
