What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Sub-fund is actively managed with reference to the MSCI World Index (NR) (the "Benchmark"), aiming to achieve the highest possible return, while taking due account of the principle of risk diversification, the security of the capital invested and the liquidity of the assets. The Investment Manager will use its discretion to significantly deviate from the weighting of certain components of the benchmark and to significantly invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities. It is thus expected that the performance of the Sub-fund will significantly deviate from the benchmark. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. To achieve its objective, the Sub-fund invests, either directly or indirectly, at least two thirds of its net assets in equities, equity-type securities and/or futures on equity indices. In addition, the Sub-fund may invest up to one third of its assets in money market instruments, bonds, notes, and other fixed or variable-interest debt instruments and rights. Up to 49% of the Sub-fund's net assets may be invested in units of other UCITS or UCIs. In addition, the Sub-fund may invest in structured products. Investments are not limited to a specific industry sector, geographic scope or market capitalization of the issuer. The Sub-fund may hold up to 20% of its net assets in ancillary liquid assets, limited to bank deposits at sight, such as cash held in current accounts. The Sub-fund can use derivative instruments for purposes of hedging and efficient portfolio management. The investor can buy or sell shares of the Sub-fund on a daily basis (Luxembourg bank business days). This Share Class does not make regular distributions. The Sub-fund shall bear the co

What are the risks and what could I get in return?

(A) Summary Risk Indicator





The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.
