## What is the product?

**Type:** This Product is a common fund qualifying as an 'other fund for traditional investments' in accordance with the Swiss Federal Act on Collective Investment Schemes.

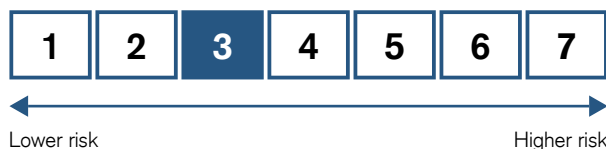
**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Management Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Bond Sub-Fund is actively managed aiming to outperform the return of the SBI Foreign AAA-BBB benchmark. The portfolio and the performance of the Sub-Fund can deviate from the benchmark. The Sub-Fund invests mainly in CHF denominated fixed income securities of corporate issuers which have at least a minimum credit rating of BBB- (Standard & Poor's). Investments in non-CHF denominated fixed income securities are fully hedged in CHF. The investor can buy or sell units of the Sub-Fund on a daily (Switzerland bank business days) basis. This Unit Class makes regular distribution. The Sub-Fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-Fund through securities transactions in relation to the portfolio.

**Intended Retail Investor:** This Product is intended for professional and institutional investors, as well as sophisticated retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

## What are the risks and what could I get in return?

### (A) Summary Risk Indicator



**The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.**

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 3 out of 7, which is a medium-low risk class. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. ### Recommended holding period: 5 years

The investor can sell their investment on a daily (on business days) basis. Redemption fees will be charged at the level of the Product.
