## What is the product?

**Type:** This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

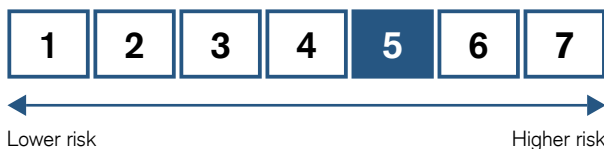
**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Equity Sub-fund is actively managed. It references the index MSCI EMU ND (in respective share class currency) (the "Benchmark") for the purpose of the performance fee calculation. The Sub-fund is aiming to achieve a capital appreciation by investing in equity securities from companies domiciled in the Eurozone over a long-term. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. The Investment Manager will use its discretion to significantly deviate from the weighting of certain components of the benchmark and to significantly invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities. It is thus expected that the performance of the Sub-fund will significantly deviate from the benchmark. The Sub-fund might also invest up to one third of its assets in equities or equity-type instruments of the issuers having their registered offices in developed countries but outside Eurozone. The Sub-fund, occasionally may hold up to 20% of its net assets in very liquid investments like cash or money market instruments. The Sub-fund may use derivative instruments to protect against currency fluctuations, market movements or for efficient portfolio management. This Share Class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

**Intended Retail Investor:** This Product is intended for professional and institutional investors, with an ability to bear an average investment loss, and a long-term investment horizon.

## What are the risks and what could I get in return?

### (A) Summary Risk Indicator



**The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.**

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 5 out of 7, which is a medium-high risk class and poor market conditions will likely impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product.
