What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

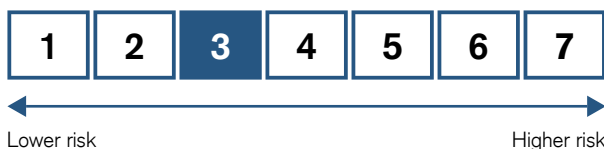
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Equity Sub-fund is actively managed. It references the index (80%MSCI AC World Net EUR Hedged and 20% FTSE 3-Month Euro Eurodeposit LCL) (in respective share class currency) (the "Benchmark") for the purpose of the performance fee calculation. The investment process is driven by a proprietary DIVAS Asset Management quantitative asset selection model, which aims to identify and exploit changes in trend while investing in global equity indices. The Investment Manager will use its discretion to significantly deviate the weighting of certain components of the benchmark and to significantly invest in companies or sectors not included in the benchmark in order to take advantage of specific investment opportunities. It is thus expected that the performance of the Sub-fund will significantly deviate from the benchmark. The Investment manager focuses on cost effective implementation of the signals derived from the model. The Sub-fund may use derivatives to achieve the above aims. The Sub-fund might invest up to 120% of its net assets in Developed Markets indices, up to 50% in Emerging Markets indices and up to 50% in Credit Default indices. In addition, the Sub-fund might also invest in structured products, such as certificates on equities, equity type securities, equity basket and equity indices issued by top global banks but not more than 20% of its net assets. Moreover, fixed-income and floating-rate securities of public, private and semi-private issuers might be also targeted as the Sub-fund's investments. The Sub-fund uses derivatives to reduce the impact of changes in currency exchange rates on the performance for this Share Class. The investor can buy or sell shares of the Sub-fund on a daily basis, as further defined in the prospectus. This Share Class does not make regular distributions. The Sub-fund shall bear the costs of standard charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 3 out of 7, which is a medium-low risk class and poor market conditions are unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator. This Product does not include any protection from future market performance so you could lose some or all of your investment.

The investor can sell their investment on a daily (on business days) basis. No redemption fees or penalties will be charged at the level of the Product.
