The Product is a UCITS Sub-fund established in Luxembourg. It is managed by Credit Suisse Fund Management S.A. (the **Management Company**).

What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

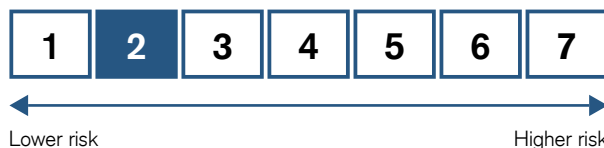
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund invests primarily in fixed income securities denominated in onshore Renminbi, collateralised debt and loan obligations, preferred securities, zero-coupon securities, structured products, mezzanine securities, senior secured floating rate and fixed rate debt, second lien or other subordinated or unsecured floating rate and fixed rate debt, convertible debt securities, money market instruments, and deposits or other callable bank deposits, and derivatives with similar economic characteristics of corporate, government and quasi-government issuers domiciled in the People's Republic of China (PRC) or which conduct the majority of their business activities there and which are traded on the two official exchanges in the PRC or on the China inter-bank bond market via the CIBM Direct schemes. This Sub-fund aims to outperform the return of the ChinaBond New Composite benchmark. The Sub-fund is actively managed. The benchmark is used as a reference point for portfolio construction and as a basis for setting risk constraints. The majority of the Sub-fund's exposure to bonds will refer and have similar weightings to the benchmark. The Investment Manager may use its discretion to invest in bonds not included in the benchmark in order to take advantage of specific investment opportunities. It is thus expected that the performance of the Sub-fund will to a limited extent deviate from the benchmark. The Sub-fund may use derivatives to achieve the above aims. The Sub-fund uses derivatives to reduce the impact of changes in currency exchange rates on the performance for this Share Class. The investor can buy or sell shares of the Sub-fund on a daily basis, as further defined in the prospectus. This Share Class does not make distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio. The official currency of the People's Republic of China is the Renminbi ("RMB"). When referred to for this Sub-fund, "Offshore Renminbi" refers to RMB traded outside the PRC, primarily in Hong Kong (also known as "CNH") and "Onshore Renminbi" refers to RMB accessible within the PRC (also known as "CNY"). Although Offshore RMB and Onshore RMB are the same currency, they are traded or offered on separate markets. Therefore they are traded at different rates and their movements may not always be in the same directions.

Intended Retail Investor: This Product is intended for professional and institutional investors, with an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 2 out of 7, which is a low risk class and poor market conditions are very unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator.
