What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product matures on 30 September 2024. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Bond Sub-fund is actively managed without reference to a benchmark aiming to maximize returns ("income") over the lifetime of the Sub-fund, which matures on 30 September 2024. The Sub-fund invests in debt instruments, bonds, notes, and similar fixed interest or floating-rate securities (including securities issued on a discounted basis) which have a minimum credit rating of B- (Standard & Poor's) or B3 (Moody's) of private, semi-private and public issuers worldwide. The Sub-fund may invest up to 100% of its net assets in public, semi-private and private issuers which are domiciled in or carry out the bulk of their business activities in the Asian region. The securities will not have a maturity longer than the maturity date of the Sub-fund. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of exclusions, ESG integration and active ownership. The most material ESG factors are combined with traditional financial analysis to calculate an ESG integrated credit rating, which serves as the basis for a bottom-up security selection process. This Sub-fund may not be suitable for investors who want to withdraw their money before 30 September 2024. The Sub-fund may use derivatives to achieve the above aims. As of 28 May 2021, the Sub-fund is closed for further subscriptions. The investor can sell shares of the Sub-fund on a daily basis, as further defined in the prospectus. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

What are the risks and what could I get in return?

(A) Summary Risk Indicator
