You are about to purchase a Product that is not simple and may be difficult to understand.

What is the product?

Type: This Product is a common fund qualifying as an 'other fund for traditional investments' in accordance with the Swiss Federal Act on Collective Investment Schemes.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Management Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Mixed Sub-fund is actively managed without reference to a benchmark. The Sub-fund invests mainly in investment funds, ETFs and other instruments to gain exposure to fixed income securities (30% - 80%), equities and equity-type securities (15% - 55%) and alternative investments (0%-20%). It invests without being limited to a specific class of assets, geographic scope or industry sector. Investments of issuers denominated in CHF will account for a larger proportion than investments in other currencies. The Sub-fund uses derivatives to reduce the impact of changes in currency exchange rates on the performance of the unit. Investor can subscribe or redeem units of the Sub-fund on every Swiss banking day. This Unit Class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for professional and institutional investors, as well as sophisticated retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 3 out of 7, which is a medium-low risk class. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, sustainability and legal risks that are not included in the Summary Risk Indicator. Recommended holding period: 5 years

The investor can sell their investment on a daily (on business days) basis. Redemption fees will be charged at the level of the Product.
