# What is the product?

Type: This Product is a common fund qualifying as an 'other fund for traditional investments' in accordance with the Swiss Federal Act on Collective Investment Schemes.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Management Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Mixed Sub-fund is actively managed without reference to a benchmark. The Sub-fund invests primarily in fixed-interest securities (25%–85%), equities and equity-related securities (10%–25%), as well as cash and cash-equivalent assets (0%–75%). The Sub-fund's investments are not restricted to any specific asset classes, regions, or industries. Most assets are placed in traditional CHF investments. Other currencies are generally fully converted into CHF. The Investment Manager gives consideration to sustainability in its investment approach by taking into account environmental, social and governance (ESG) factors and the related sustainability risks in the investment decision making process, in addition to risk and return considerations.

**Intended Retail Investor:** This Product is intended for professional and institutional investors, as well as sophisticated retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

## What are the risks and what could I get in return?

(A) Summary Risk Indicator
