What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund invests in fixed income securities (including fixed rate bonds, zero-coupon bonds, government bonds, semi-government bonds, corporate bonds, inflation-indexed debt securities, bonds of emerging market issuers, bonds of supranational organizations, high-interest and convertible bonds and notes, zero-coupon bonds, subordinated bonds, covered bonds, perpetual bonds and collateralized debt obligations) but also in floating rate notes which have a credit rating between AAA and D (Standard & Poor's) or Aaa and C (Moody's). The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of exclusions, ESG integration and active ownership. The most material ESG factors are combined with traditional financial analysis to calculate an ESG integrated credit rating, which serves as the basis for a bottom-up security selection process. The strategy of sector rotation is being used for the sake of anticipating economic recovery and contractions in different sectors of the economy, as the global economy moves in cycles. This Sub-fund aims to outperform the return of the benchmarks depending on the reference currency of the relevant share class as follows: CHF: SARON + 1.00% p.a., EUR: ESTR + 1.00% p.a., USD: SOFR + 1.00% p.a. The Sub-fund is actively managed. The benchmark is used as a reference point for determining the long term target performance that the Sub-fund intends to achieve whatever the market conditions are. It is thus expected that the performance of the Sub-fund will to a significant extent deviate from the benchmark. There are however market conditions that may result in the performance of the Sub-fund applies a diversified long-short strategy entailing the use of derivatives such as futures, swaps, options and credit derivatives. (A) Summary Risk Indicator
