### What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

**Term:** This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

**Objectives:** This Bond Sub-fund is actively managed without reference to a benchmark aiming to maximize returns ("income") over a medium to long term. The Sub-fund invests in fixed income securities (including fixed rate bonds, zero-coupon, subordinated, perpetual bonds, contingent capital instruments and other hybrid bonds), covered bonds, notes, and similar fixed interest or floating-rate securities (including floating rate notes and securities issued on a discount basis) which have a minimum credit rating of CCC- (Standard & Poor's) or Caa3 (Moody's), issued by private, semi-private and public issuers worldwide and denominated in any currency. It invests without being limited to a specific class of assets, geographic scope or industry sector. The Sub-fund can shift its allocation towards securities that might be undervalued by the market but with expected improvement and uses derivatives to achieve the above aims. The Sub-fund uses derivatives to reduce the impact of changes in currency exchange rates on the performance for this Share Class. The investor can buy or sell shares of the Sub-fund on a daily basis, as further defined in the prospectus. This Share Class makes regular distribution. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors as well as institutional investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

### What are the risks and what could I get in return?

### (A) Summary Risk Indicator





The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 3 out of 7, which is a medium-low risk class and poor market conditions are unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product.
