What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

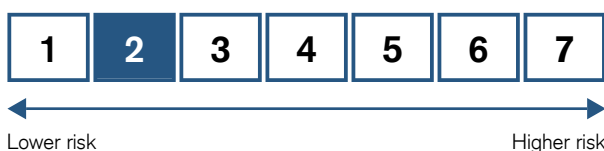
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Bond Sub-fund is actively managed without reference to any benchmark, aiming to achieve a capital appreciation in the long term by investing its assets primarily in bonds while taking into account the principles of risk spreading and assuming a moderate degree of risk. The Sub-fund may invest up to 100% of net assets in bonds, notes and other fixed income or floating rate secured or unsecured securities issued by public authorities, semi-public enterprises or private borrowers, as well as in similar securities. The Sub-fund will select these fixed income or floating rate securities irrespective of their rating and may also invest in securities below investment grade (i.e. below "BBB-" (S&P) or "Baa3" (Moody's) and such securities which are not rated. Up to 20% of the Sub-fund's net assets may be invested in deposits with credit institutions in all currencies, as well as all types of asset backed securities (ABS), structured products, and/or in Target Funds. The Sub-fund may invest up to 100% of its net assets in Target Funds including UCITS compliant ETFs. The Sub-fund invests without being limited to a specific currency, geographic scope, industrial sector or rating of the issuer (including non-investment grade securities). In order to achieve its objective, the Sub-fund can use derivative instruments to protect against movements in currencies and security prices and for efficient portfolio management. The investor can buy or sell shares on a daily basis (Luxembourg bank business days). This Share Class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for professional and institutional investors, with an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 2 out of 7, which is a low risk class and poor market conditions are very unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product.
