What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Equity Sub-fund is actively managed aiming to achieve long-term capital growth that is above the benchmark (Swiss Leaders Index (TR) in CHF) by investing mainly in equities and equity-type securities of companies listed on a Stock Exchange in Switzerland. While a large part of the investments of the Sub-fund will be components of the benchmark which will also have similar weights as the benchmark, the Sub-fund manager has discretion to invest in other securities not included in the benchmark. The Sub-fund does not track the benchmark precisely but tries to exceed its performance subject to an internally applied deviation limit and may therefore differ from it moderately— both positively and negatively. The Investment Manager will use its discretion to overweight or underweight certain components of the Benchmark. The Sub-fund may invest up to 1/3 of its net assets in investment grade fixed-income or floating rate securities denominated in CHF. It can use derivative instruments for investment purposes and for efficient portfolio management. The investor can buy or sell shares on a daily basis (Luxembourg bank business days). This Share Class does not make regular distributions. The Sub-fund shall bear the costs of standard brokerage and bank charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for professional and institutional investors, with an ability to bear an average investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator





The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets.
